Sterilisation will documented by the producer as follows per batch:

The sterilization is done with EO-Gas sterilization at 22-24 C at 75% EO Gas and 90% CO2. The period of time is 7 hours at 35 % relativ air moisture. After this step the EO Gas is eliminated through compulsive vatinlating for 2 hours.
